Professional History:

1997-Present

Clyde Henry is a co-founder of TRIAD Architects. He served as the firm's first president for five years, bringing TRIAD Architects from a firm of four persons to one of Columbus' ten largest firms. Working with BASA (Buckeye Association of School Superintendents), he developed the BASA/TRIAD Facility Conference and Exposition. He also created a series of statewide workshops with the Ohio Library Council. He developed CROSSROADS™, a community-based school design and planning program. CROSSROADS™ has been recognized by the KnowledgeWorks Foundation and the Rural School and Community Trust as an effective and authentic community participation program. This program has successfully united communities in support of school projects throughout the state and has been the subject of numerous publications. During his presidency, nearly a third of a billion dollars of design was initiated. He currently continues to serve as a partner, as Chairman of the Board, and a lead designer.

1987-1997

Clyde Henry served as a partner with MCB Architects. During this time, he initiated workshop programs for school superintendents and others interested in educational design. In addition, he developed some of Ohio's first community involvement programs for school design. He also successfully completed the firm's most significant project, completing renovations and additions to the Brumback Library in Van Wert, Ohio which is the nation's oldest county public library in the United States. This project propelled the firm to national recognition.

1976-1987

Prior to his architectural career, Clyde Henry founded The Learning Tree in 1976. The Learning Tree operated to meet the needs of Ohio children and parents in a comprehensive educational setting. The three locations offered newborn care, preschool, language, dance and art programs, as well as full daycare, after school care and tutoring. Day camps were operated in the summer months. The Learning Tree even operated its own transportation system. In addition to meeting the needs of mainstream children, it also excelled at meeting the requirements of special need and handicapped children.

1973 – 1975

Clyde Henry served as the Director of the Art Department at the Education Center of Bonao, Dominican Republic. During his service at the school he participated in its accreditation as the world's first American Accredited bilingual school. The school met the needs of Pre-Kindergarten through High School students from fifty-four nations. Seven languages were taught at the schools as well as world curriculum that met the needed of both the local educational system and those of the student's home countries.

Historical Projects:

Greenfield Exempted Village Schools, Greenfield, Ohio

Clyde Henry completed work with the Greenfield Exempted Village School District, where a \$37 million district-wide renovations and additions have turned their historic buildings into elegant, state-of-the-art school facilities that are equipped for long-distance learning, media retrieval, and increased computer use. This project included historic renovations to Edward Lee McClain High School, Greenfield Middle School, Greenfield Elementary School, Buckskin Elementary School, and Rainsboro Elementary School. The 1915 McClain High School was honored with a National Preservation Award from the National Trust for Historic Preservation. The AIA/OSFC Excellence Award, The high school media center also received a design award from the *2001 American School & University Interior Showcase*.

Cambridge City Schools, Cambridge, Ohio

After leading a series of community-based planning meetings, Clyde Henry worked with school and community members to address their ideas and desires. The community expressed a desire to create a campus atmosphere, while placing specific grades in separate buildings. At a cost of \$38 million, the 150-acre Cambridge Campus incorporated an elementary school building, a middle school building, and a high school building, while maintaining separate grade groupings. Clyde created a solution in which each school can be viewed as the site winds back, integrating students with a sense of community to their present, past and future schools.

Elmwood Local School District, Bloomdale, Ohio

Elmwood's new \$27 million, K-12 Campus resulted from a solution Clyde Henry created with the community, that would allow the school district to combine all grade levels, but would separate elementary school, middle school, and high school classrooms into three distinct academic wings. It was a community priority to increase technology; therefore Clyde developed a technology control center housing a central media retrieval system, security system, and all other technical services including long distance learning and interactive learning.

Wellston City Schools, Wellston, Ohio

Wellston City Schools decided to build a new High School building and a combined elementary/intermediate school, with a total project budget of \$27 million. One of the school district and community's greatest concerns for this plan was site selection. Clyde Henry worked with the city and school district to secure a site composed of a mix of purchased land, donated land, and an abandoned coal field. This process helped to unify the citizens resulting in the reenergizing of the community and the school district
