

**Amendment #1 to
Grant Agreement**

This Amendment #1 to Grant Agreement (this “**Amendment**”) is entered into as of the date of last signature below (the “**Amendment #1 Effective Date**”) by and between The Barack Obama Foundation, a District of Columbia nonprofit corporation having 501(c)(3) status under the Internal Revenue Code (the “**Foundation**”), and City of Columbus - MBK Columbus, an entity formed under the laws of Ohio (“**Recipient**”).

RECITALS

- A. Recipient and the Foundation previously entered into that certain Grant Agreement, dated November 4, 2025 (the “**Original Agreement**”), pursuant to which the Foundation agreed to make a Grant to the Recipient in support of certain of Recipient’s activities.
- B. Recipient and the Foundation desire to amend the Original Agreement and to set forth herein the terms of such amendment.

In consideration of the mutual promises set forth herein, Recipient and the Foundation (individually a “**Party**” and together the “**Parties**”) agree to amend the Original Agreement as follows:

- 1. Amendments to the Original Agreement. As of the Amendment #1 Effective Date, the Original Agreement is hereby amended as follows:
 - a. **Section 3(a)** of the Original Agreement is hereby deleted in its entirety and replaced with the following:

“This Agreement commences on the Agreement Effective Date and expires on December 31, 2026, unless earlier terminated as provided herein (the “**Term**”). Any right or duty of a Party based on either performance or a breach of this Agreement prior to the effective date of termination shall survive such termination.”
 - b. **Section 1(a)(i) of Exhibit C** to Original Agreement is hereby deleted in its entirety and replaced with the following:

“A final spending report (in form, substance and detail reasonably acceptable to the Foundation) outlining the Grant Activities and a summary of receipts and expenditures with an itemized statement of costs incurred by Recipient in performance of the Grant Activities due on or before December 31, 2026.”
- 2. Effect of this Amendment. The Parties acknowledge and agree that the Original Agreement governs all services and deliverables provided by the Recipient to the Foundation, including all services and deliverables described in any amendment, additional statement of work, or change order, including this Amendment, and that the Original Agreement supersedes any and all of Recipient’s external, standard or click-through terms and any and all Recipient terms and conditions that may be attached to any Recipient proposal, invoice, bill, receipt, purchase order, or other similar document. In the event of any discrepancy or conflict between the Original Agreement, as amended, and any Recipient external, standard or click-through terms or any terms or conditions attached to any Recipient proposal, invoice, bill, receipt, purchase order, or other similar document, the Original Agreement, as

amended, shall prevail. All terms and conditions of the Original Agreement not expressly modified by this Amendment remain valid and unchanged, and all terms used but not defined in this Amendment shall have the same meaning as in the Original Agreement.

3. Counterparts. This Amendment may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument.
