DESCRIPTION OF 0.031 ACRES
Temporary Easement
B&Y Group, LLC
3350 Cleveland Ave

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 1, Township 1 North, Range 18 West, United States Military Lands and being part of 1.006 acres tract of land described in a deed to B&Y Group, LLC by deed of reference in Instrument No. 201403170032314. All references to records herein are those located in the Recorder's Office of Franklin County, Ohio and being more particularly described as follows:

Commencing at the intersection of the easterly right of way for Cleveland Avenue (width varies) as conveyed to the Franklin County Commissioners in Deed Book 3340, Page 733, with the north line of the grantor's 1.006 acres tract, said intersection being the northwest corner of the grantor's tract;

Thence **S 20 degrees 27 minutes 31 seconds W** a distance of **139.03 feet** with the easterly right of way line for Cleveland Avenue and the west line of the grantor's tract to a point;

Thence **S 69 degrees 32 minutes 29 seconds E** a distance of **3.00 feet** across the grantor's tract to a point, said point being the *TRUE POINT OF BEGINNING*;

Thence continue **S 69 degrees 32 minutes 29 seconds E** a distance **32.00 feet** across the grantor's tract to a point;

Thence **S 20 degrees 27 minutes 31 seconds W** a distance of **70.00 feet** across the grantor's tract to a point;

Thence **N 69 degrees 32 minutes 29 seconds W** a distance **35.00 feet** across the grantor's tract to a point in the easterly right of way line for Cleveland Avenue, being also the grantor's west line;

Thence **N 20 degrees 27 minutes 31 seconds E** a distance **8.00 feet** with the easterly right of way line for Cleveland Avenue and the grantor's west line to a point;

Thence **S 69 degrees 32 minutes 29 seconds E** a distance of **24.00 feet** across the grantor's tract to a point;

Thence **N 20 degrees 27 minutes 31 seconds E** a distance of **44.00 feet** across the grantor's tract to a point;

Thence **N 69 degrees 32 minutes 29 seconds W** a distance **21.00 feet** across the grantor's tract to a point;

Thence **N 20 degrees 27 minutes 31 seconds E** a distance **18.00 feet** across the grantor's tract, to the ***TRUE POINT OF BEGINNING***, containing 0.031 acre of land more or less.

The above described area contains a total of **0.031 acres** within Franklin County Auditor's Parcel Number 010-214339-00, which includes 0.000 acres in the present road occupied.

Grantor claims title by Instrument recorded in Instrument No. 201403170032314 in the records of Franklin County, Ohio.

Bearings used in this description are based on Ohio State Plane Coordinate System, South Zone as per NAD 83 and were established utilizing ODOT's VRS System, GPS equipment and procedures and established bearing of N 20°27'31" E on the centerline of Cleveland Avenue.
