[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1, Range 18 West of the United States Military Lands, being a part of Lot 26 of Highway Park as recorded in Plat Book volume 14, page 9 (all document references are to the records of Franklin County unless otherwise stated), and being a **0.008 acre** parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-074480** as conveyed to **Goldman Properties, LTD.** (hereafter referred to as "Grantor") by the instrument filed as **Instrument Number 200110120236342**, and being more particularly described as follows:

Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

BEGINNING at a point at the southwest corner of the Grantor, the southwest corner of the said Lot 26, the southeast corner of Lot 25 of the said Highway Park, the southeast corner of that tract conveyed to E & J Five LLC, a Limited Liability Company by the instrument filed as Instrument Number 201508210116786, and on the existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way line of Hudson Street station 74+30.50, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the westerly line of the Grantor, the westerly line of the said Lot 26, the easterly line of the said Lot 25, and the easterly line of the said E & J Five LLC, a Limited Liability Company tract, **North 03 degrees 38 minutes 12 seconds East for a distance of 7.00 feet** to a point being 37.00 feet left of the centerline of right-of-way of Hudson Street station 74+30.53;

Thence crossing through the lands of the Grantor, the following three (3) courses:

1. **North 86 degrees 41 minutes 06 seconds East for a distance of 25.69 feet** to a point being 40.00 feet left of the centerline of right-of-way of Hudson Street station 74+56.05;
2. **South 86 degrees 36 minutes 37 seconds East for a distance of 5.71 feet** to a point being 40.00 feet left of the centerline of right-of-way of Hudson Street station 74+61.76;
3. **South 58 degrees 16 minutes 27 seconds East for a distance of 10.53 feet** to a point on the easterly line of the Grantor, the easterly line of the said Lot 26, the westerly line of Lot 27 of the said Highway Park, and on the westerly line of that tract conveyed to David J. Ramirez and Colleen D. Ramirez by the instrument filed as 201701130007318, said point being 35.00 feet left of the centerline of right-of-way of Hudson Street station 74+71.03;

Thence along the said easterly line of the Grantor, the said easterly line of Lot 26, the said westerly line of Lot 27, and the said westerly line of the David J. Ramirez and Colleen D. Ramirez tract, **South 03 degrees 37 minutes 19 seconds West for a distance of 5.00 feet** to a point (being referenced by a ¾" iron pipe found bearing North 59 degrees 30 minutes 58 seconds East a distance of 0.12 feet), said point being at the southeast corner of the Grantor, the southeast corner of the said Lot 26, the southwest corner of the said Lot 27, the southwest corner of the said David J. Ramirez and Colleen D. Ramirez tract, and on the said existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 74+71.01;

Thence along the southerly line of the Grantor, the southerly line of the said Lot 26, and the said existing northerly right-of-way of Hudson Street, **North 86 degrees 36 minutes 37 seconds West for a distance of 40.51 feet** to the **TRUE POINT OF BEGINNING** of the parcel herein described.

The above description contains a total area of **0.008 acres (0.000 acres** are located within the Present Road Occupied resulting in a net take of **0.008 acres**), all of which are located within Franklin County Auditor's **Parcel Number 010-074480**.

Prior instrument of record as of this writing recorded in **Instrument Number 200110120236342** in the records of Franklin County.

This description was prepared by Andrew T. Jordan, Ohio Registered Professional Surveyor number 8759, and is based on an actual field survey conducted by American Structurepoint Inc., and is true and correct to the best of my knowledge and belief.

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
