Thank you for the continued interest you have expressed in Motorola communication system products. Motorola is in the process of, or has supplied and installed consoles with furniture in Westerville, Clermont County, Hilliard, Canton and Cincinnati. In addition to these references below are some compelling reasons to procure the new console and dispatch furniture from Motorola, as part of the overall project:

Eliminates time and overhead costs associated with additional separate procurement of furniture by Columbus. This dispatch operation will require close coordination due to size of the existing and new systems being contemplated.

Motorola is uniquely qualified to design, coordinate and implement a system of this magnitude and complexity. Similar to radio system installations that include third party manufactured antennas, combiners and grounding equipment, it is widely accepted that the primary vendor apply consistent standards for design, manufacture, shipment coordination and implementation in large projects such as this.

Eliminates need for City personnel to manage the ordering, tracking, receiving, and installation of furniture. This is compounded by the fact that coordination impacts a live public safety dispatch center.

Provides the primary benefit of a single point-of-contact relative to radio dispatch console equipment and furniture procurement, tracking, delivery, installation and acceptance testing.

Allows greater schedule control, installation control, and human resource control by eliminating need for Columbus to manage furniture procurement, tracking, delivery and installation.

Reduces project management time and effort relative to managing a third party furniture procurement, scheduling and installation into a live public safety dispatch center.

All activities relative to the console/furniture are coordinated by single entity rather than two or three entities, (Columbus, third party & Motorola).

Motorola will be able to provide the dispatch center furniture to the specification of the console equipment requirements and user requirements, eliminating the possibility of obtaining a 'low bid' furniture package and associated problems.
