Design, construction and operation of the OWRRS Facility for processing of wastewater treatment plant (WWTP) sewerage sludge, processing of WWTP sewerage sludge incinerator ash, and operation and maintenance of the City's trucked waste disposal facility (TWDF).

#### 6. An updated contract timeline to contract completion.

Contract terms are ten (10) years in duration and may be extended for an additional five (5) year period, at the option of Kurtz Bros., Inc. The ten-year completion dates are as follow:

WWTP sewerage sludge incinerator ash processing – ending on 10/23/2018

TWDF operation and maintenance – ending on 12/01/2019

WWTP sewerage sludge processing – ending on 12/01/2020.

The costs for the processing of sewerage sludge and incinerator ash and for operating and maintaining the City TWDF are comparable to the costs of other methods of byproduct use and disposal currently employed by the City. This contract allows the City to continue to diversify processes and involve a local private business to cooperatively divert useful byproducts from the county landfill. This project will extend the life of the county landfill and increase the beneficial uses of WWTP byproducts.
