Background: The Income Tax Division requested proposals in 2004 through the Purchasing Office and these proposals were evaluated by a committee of representatives from the Income Tax Division, the Department of Technology, the Deputy Auditor and the City Treasurer. It was determined that First Data Government Solutions, formerly GovConnect, had the municipal government experience and product that would best serve the needs of the City and its taxpayers. First Data Government Solutions, Inc. currently provides Income Tax E-File/E-Pay services and Pay-by-Phone and Pay-by-Web services for the Parking Violations Bureau.

It was intended that the initial contract for the electronic payment services provided to the Income Tax Division would be the basis for the web platform for electronic payment services to other agencies in the City including the Department of Public Utilities. Due to these existing interfaces between the City's web platform and the e-payment engine provided by First Data Government Solutions, it was recommended that the Department of Public Utilities also use their services for its electronic payment requirements.
