- \* (2) Regular body tandem axle regular plow diesel dump trucks (one-for-one trades once delivered): 2 @ \$311,843 = \$ 623,686
- \* (6) Regular body single axle regular plow diesel dump trucks (one-for-one trades once delivered): 6 @ \$290,533 = \$1,743,198
