COED Letter of Agreement Revised 8.1.2025

This Office Space Lease Agreement ("Agreement") is prepared by The Saunders Company, LLC, hereinafter referred to as "Tenant," and is submitted to Derrick Pannell, owner of C.O.E.D. hereinafter referred to as "Landlord," on April 26, 2024, **and revised on August 1, 2025** to reflect a move in location within the building. The Tenant agrees to lease office space as specified below, under the terms and conditions outlined in this document.

Premises Description:

Tenant proposes to lease the office space located at the C.O.E.D. 1890 E. Main Street, specifically Suite 204 on the second floor ("Premises"). The desired configuration of the Premises includes:

- Two unfurnished office spaces (204 A and B) which includes one receptionist office and one CEO office with the ability to lock each office;
- Three fully outfitted cubicles, each fully equipped with filing cabinets that have locks, desks, and chairs (one desk-style chair and one regular sitting chair); access to kitchenette, open space for seating on the 2nd floor;
- Access to Wi-Fi 24/7, electricity and general utilities; and
- Access to C.O.E.D. amenities, including, but not limited to, the weight room (excluding the hours of 5a-8a and 5p-8p), the conference room (must be reserved in advance), co-working space, restrooms and use of standing monitors upon request.

Lease Term:

Tenant proposes a revised lease commencement date of **August 1, 2025**, with provisions for early termination upon 60 days' written notice from either party.

Monthly Rent:

Tenant agrees to a revised monthly rent of \$2,500, payable in advance on the first day of each month. Rent for any partial month at the beginning or end of the lease term will be prorated based on the actual number of days in that month.

Use of Premises:

The Premises will be used solely for purposes related to the execution of business related to the services of TSPRG and will be maintained so as not to disturb the peace and quiet of other tenants in the building.

Maintenance and Repairs:

Landlord will maintain the Premises in good and sanitary condition, and the Tenant will maintain the leased offices at Tenant's own expense (excluding electricity and general utilities), throughout the duration of the lease. Tenant acknowledges that Landlord is responsible for structural repairs and maintenance of common areas.

Utilities and Services:

Landlord will be responsible for all associated utilities and services. Tenant requests full access to Wi-Fi 24/7, as well as full use of building amenities including the weight room, conference room, co-working space, and electricity and utilities as part of the lease terms.

Alterations:

Tenant will seek Landlord's written consent before making any alterations to the walls, partitions or any structural component of the Premises.

Miscellaneous:

This Agreement is governed by the laws of the State of Ohio.


