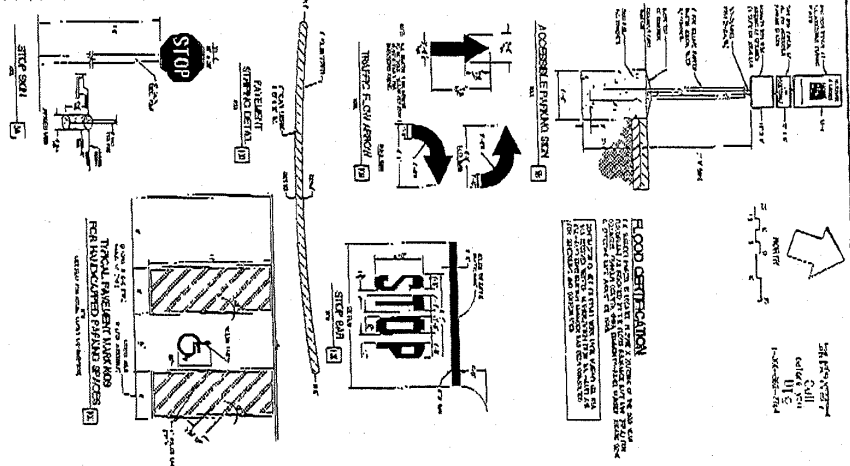


**MURPHY OIL
