ENCROACHMENT EASEMENT

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 13, Township 5, Range 22, Refugee Lands, and being a portion of right of way of Mount Vernon Avenue, as originally dedicated in East Grove Addition, of record in Plat Book 2, Page 102. All records being of record in the Franklin County Recorder's Office, Franklin County, Ohio and being more fully described as follows:

Commencing at a mag spike found at the centerline intersection of Mount Vernon Avenue (variable R/W width) and Monroe Avenue (R/W width 66');

Thence **South 77 degrees 28 minutes 32 seconds West** a distance of **44.33 feet** with the centerline of Mount Vernon Avenue;

Thence **South 12 degrees 31 minutes 28 seconds East** a distance of **32.00 feet** across the right of way of Mount Vernon Avenue to the ***True Point of Beginning***;

Thence **South 12 degrees 31 minutes 28 seconds East**, continuing across the right of way of Mount Vernon Avenue, a distance of **1.00 feet** to the southerly existing right of way of Mount Vernon Avenue, being at the intersection of the southerly existing right of way of Mount Vernon Avenue and the westerly right of way of Monroe Avenue, also being the northeast corner of Lot 1 of said George A. Powells Heir's Subdivision as conveyed to Efrain Quezada in Instrument Number 202107160125869;

Thence **South 77 degrees 28 minutes 32 seconds West**, with said southerly existing right of way of Mount Vernon Avenue and the north line of said Lot 1, a distance of **42.38 feet**;

Thence **North 12 degrees 31 minutes 28 seconds West**, leaving said southerly existing right of way of Mount Vernon Avenue and the north line of said Lot 1, a distance of **1.00 feet** across the right of way of Mount Vernon Avenue;

Thence **North 77 degrees 28 minutes 32 seconds East** a distance of **42.38 feet** across the right of way of Mount Vernon Avenue to the ***True Point of Beginning***.
