As you know, the University Area Review Board (UARB) is charged with protecting the architectural character and promoting good design solutions for commercial and residential properties in the Impact District as outlined in the University Area Planning Overlay (C.C. 3372.500). The UARB meets once a month to review proposed alterations to buildings, sites and structures under its jurisdiction and to make decisions on the appropriateness of each proposal.

The UARB is comprised of representatives from several different constituencies; three from the American Institute of Architects (AIA), one from the Area Commission (UAC), one from the Business Association (UCBA), one from the Apartment Association (CAA) and one At-Large. All board members are appointed by the Mayor for three-year terms and serve without compensation.

The term of Ms. Doreen Uhas-Sauer, the At-Large representative to the Board, expired January 31, 2016. Ms. Uhas-Sauer has served exceptionally as a member of the UARB since 1993, is the current UAC President and is a tremendous asset to the Board. She is a long time resident (early 1960's) and chronicler of the University District.

In the attached letter and supporting material, educator, preservationist and neighborhood activist Doreen Uhas-Sauer, has indicated he wishes to seek reappointment to the UARB. The Planning Division recommends the reappointment of Ms. Uhas-Sauer to the UARB. Her new term would expire January 31, 2019.
