Provide for design of sanitary sewer to serve properties in the vicinity of Merwin Hill Drive near the intersection of McCutcheon and Stelzer Roads.

It is anticipated that the project will begin in 11/2006 and conclude in 2010. The completion date is subject to successful acquisition of the necessary easements and completion of the assessment process.

- 4. An estimate of the full estimated cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.**

The current anticipated cost of this project is \$402,897.65, which includes the cost of this design contract, projected easement acquisition and construction costs.

Korda/Nemeth has developed engineering construction plans for the sanitary sewer. Easement acquisition, assessment process and construction has not yet begun.

It is still anticipated that this project will conclude in 2010.

No modifications to date.

Preparation of construction plans for the replacement of an existing 24” culvert under McCutcheon Road.

The contract was originally scoped for the design of a sanitary sewer (assessment) within the area of Merwin Hill Drive. During field review the need for a culvert replacement under McCutcheon Road was identified within the project alignment.

8. **An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation.)**

Korda/Nemeth has already acquired sufficient survey data to provide design of the culvert but cannot utilize the current funding source (sanitary) in the original contract for the design of a stormwater culvert (different funding source).

9. **A cost summary to include the original contract amount, the cost of each modification to date (list each modification separately), the cost of the modification being requested**

in the legislation, the estimated cost of any future known modifications and a total estimate of the contract cost.

Original contract amount: \$402,897.65

No existing modifications.

Requested modification: \$16,909.84
