located west of Parsons Avenue and north of Kennedy Drive and generally extending from the southeast corner of Parsons Avenue and Mooberry Street, east to the southwest corner of Mooberry Street and the first alley east of and parallel with Eighteenth Street, south to the northwest corner of the first alley east of and parallel with Eighteenth Street and Livingston Avenue, south to the southeast corner of Livingston Avenue and Heyl Avenue, west to the southeast corner of Jackson Street and Putnam Street, west to the southwest corner of Jackson Street and Parsons Avenue, and north to the northwest corner of Parsons Avenue and Denton Alley, north and west to the southwest corner of Livingston and Parsons Avenues, north to the northwest corner of Parsons Avenue and Mooberry Street (excluding all of Livingston


BACKGROUND:


- The 52.7± acre site is developed with the Children's Hospital and related medical research, office, heliport, and parking facilities. The main purpose of the application is to add 0.64 acres at the corner of Livingston and Heyl Avenues to the existing Commercial Planned Development District that already comprises 52.1± acres.
- No changes of substance are being made to the text except for updates to account for the addition of the site and to eliminate limitations that were made unnecessary with the adoption of the new parking chapter in the Zoning Code.

- To the north of the 0.64 site being across Livingston Avenue is a Childhood League Center zoned in the CPD, Commercial Planned Development District. To the south across the alley are single-unit dwellings zoned in the R-2F, Residential District. To the east across Heyl Avenue is an elementary school zoned in the AR-1, Apartment Residential District. To the west is a nonconforming two-unit dwelling owned by the applicant and zoned in the CPD, Commercial District.
- The site falls within the boundaries of the Near Southside Plan (1997), which is being updated.
- The Columbus Thoroughfare Plan identifies East Livingston Avenue as a 4-2D arterial requiring a minimum of 60 feet of right-of-way from centerline.

<u>CITY DEPARTMENTS' RECOMMENDATION</u>: Approval.

The proposed modification to the CPD Plan and Text would allow for orderly expansion of the hospital and associated facilities and is consistent with the development and zoning patterns of the area. The rest of the changes are to update the text and eliminate limitations that are no longer needed due to improvements in the Zoning Code.





700 Childrens Drive: CSSAC voted for approval with following conditions: no parking garage to be built on corner of Livingston and Heyl. Maximum building height at same corner to be 45'. Building design will be presented to Southern Orchards Civic Association and CSSAC before final plans to build on corner of Livingston and Heyl. NCH was in agreement with all the conditions mentioned.
