This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Pedestrian Safety Improvements – N. Broadway and S. High Sidewalks-Highview to Williams Road project.

Project Scope:

The project will consist of: new sidewalk construction on the south side of North Broadway between the Upper Arlington Corporation Line and Shattuck Avenue, the north side of North Broadway between the Upper Arlington Corporation Line and the COTA bus stop 300' west of the Riverside Hospital entrance, on both sides of High Street between Highview Boulevard and Williams Road.

Fiscal Impact: Source of funds is 2012 bonds.

Engineer's estimate + 20% inspection: \$527,884.00
Low bid amount + 20% inspection: \$407,012.64
Difference between engineer's estimate and bid amount, with inspection: \$120,871.63

Schedule: Bids were opened June 12, 2012; estimated Council date is July 9, 2012; estimated NTP date is August 3, 2012. The contract has a completion date of June 1, 2013. An interim completion of December 31, 2012, is applicable to all bid items except seeding and mulching which will be completed by June 1, 2013.

Engineer's Estimate: \$439,903.33

Evaluation Findings:

Nickolas M. Savko & Sons answered yes to question HE-7 – Safety Compliance – OSHA, an investigation provided the following details:

- February 22, 2012, a planned OSHA inspection to the worksite at 1151 Idlewild Drive in Reynoldsburg, Ohio, found inadequate trench protection for workers. According to OSHA records this violation has been settled.

Recommendation:

With reference to bids received on June 12, 2012, I wish to make the following recommendation for the subject improvement:

Award is made to the lowest responsive and responsible and best bidder, Nickolas M Savko & Sons, Inc., for their bid of \$339,176.97, which is \$100,726.36 under the Engineer's estimate of \$439,903.33.

Nickolas M Savko & Sons, Inc. did complete the Construction Contract Subcontractor Report. All of the subcontractors contacted were chosen to be subcontractors on the project.

Please respond to this e-mail indicating approval of the recommended contractor – Nickolas M Savko & Sons, Inc. – or approval of another contractor. If you approve another contractor please provide an explanation.
