

The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 1783701. The permit holder received a D1, D3, D3A, & D6 permit. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for on premises consumption as described by Ohio Law.

An "Inquiry of Violations" was received from the State of Ohio, Division of Liquor Control. The inquiry revealed that the permit holder has received the following administrative violations within the past 12 months

Case Number: 01

09/06/2014

The Permit Holder has been charged with the violation of Sale and/or Furnishing to a Person Under 21. This case has not been assigned a case number by the Liquor Control Commission.

Case Number: 02

03/25/2014

The Permit Holder has requested and received a member transfer, which was approved on 10/22/2014. This case has not been assigned a case number by the Liquor Control Commission.

Case Number: 03

12/21/2011

The Permit Holder has been charged with the violation of Failure to Pay Job Serves. This case has been assigned case number 14uc12 by the Liquor Control Commission. The case was dismissed by the Liquor Control Commission on 03/01/2012.

Case Number: 04

09/17/2010

The Permit Holder has been charged with the violation of Minor Consuming Alcoholic Beverage. This case has been assigned case #14-11 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 12/15/2011, at which time the Commission sustained the violation. The commission ordered a 3 day suspension of the permit or that the Permit Holder pay a \$300 fine. The permit Holder paid the fine on 03/02/2011.
