The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 7149985 The permit holder received a C1, C2, and D6 permit. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for off premises consumption as described by Ohio Law.

An "Inquiry of Violations" was received from the State of Ohio, Division of Liquor Control. The inquiry revealed that the permit holder has received the following administrative violations within the past 12 months

The Permit Holder has been charged with the violation of Sale and/or Furnishing to a Person Under 21. This case has not been assigned case by the Liquor Control Commission. This case is pending before Ohio Liquor Control Commission

The Permit Holder has been charged with the violation of Improper Conduct – Receiving and/or Concealing Stolen Property. This case has been assigned case #1151-14 by the Liquor Control Commission. This case is pending before Ohio Liquor Control Commission

The Permit Holder has been charged with two violations, first one, Improper Conduct – Receiving and/or Concealing Stolen Property and Improper Conduct – Illegal possession of E.B.T. This case has been assigned case #1152-14 by the Liquor Control Commission. This case is pending before Ohio Liquor Control Commission

Case Number: 03

The Permit Holder has been charged with the violation of, Sale and/or Furnishing to a Person Under 21. This case has been assigned case #476-14 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 6/04/2014, at which time the Commission sustained the violation. The commission ordered that the permit revoked or the permit holder pay \$4,000. The permit Holder paid the fine on 7/17/2014.

The Permit Holder has been charged with the violation of, Sale and/or Furnishing to a Person Under 21. This case has been assigned case #93-14 by the Liquor Control

Commission. This case was heard by the Ohio Liquor Control Commission on 02/05/2014, at which time the Commission sustained the violation. The commission ordered a 6 day suspension or the permit holder pay \$1,500 fine. The permit Holder paid the fine on 03/19/2014.

The Permit Holder has been charged with the violation of, Permit Not Posted in Conspicuous Place. This case has been assigned case # 1161-13 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 10/09/2013, at which time the Commission sustained the violation. The commission ordered a 6 day suspension or the permit holder pay \$750 fine. The permit Holder paid the fine on 11/22/2013.
