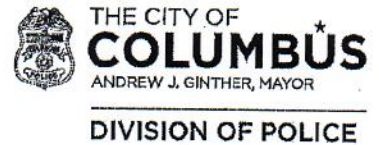

Sir,

The following investigation was conducted concerning the City of Columbus' 2017 annual objection to the renewal of liquor permit **98628350010** issued to **Yousef D 1023 LLC**, which is doing business as **Town Market (Vans Market)** located at **1270 W Town St. Columbus, Ohio 43222**. The recorded owner of said permit is **Isaam Yasin**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C-1**, and **C-2** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.


