[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Quarter Township 4, Township 1, Range 18, United States Military District, being on, over and across Lot 56 of that subdivision titled "American Addition", of record in Plat Book 5, Page 448, conveyed to Vanzella Douthitt, Lester Douthitt, Wesley Douthitt, Althenia Douthitt Cooper, Alfreda Douthitt Nichols, Weldon Douthitt, James Douthitt Jr., Juanita Douthitt Clayborn, William Douthitt, and Jeanne Douthitt Morris by deed of record in Official Record 7323A19 (all references refer to the records of the Recorder's Office, Franklin County, Ohio) being more particularly described as follows:

BEGINNING at the northeasterly corner of said Lot 56 and the southeasterly corner of Lot 57 of said "American Addition", being in the westerly right-of-way line of Cushing Alley (20 feet wide);

Thence South 04° 06' 54" West, with said westerly right-of-way line, a distance of 35.00 feet to the southeasterly corner of said Lot 56 and the northeasterly corner of Lot 55 of said "American Addition";

Thence North 85° 53' 11" West, with the line common to said Lots 56 and 55, a distance of 3.00 feet to a point;

Thence North 04° 06' 54" East, crossing said Lot 56, a distance of 35.00 feet to a point in the line common to said Lots 56 and 57;

Thence South 85° 53' 11" East, with said common line, a distance of 3.00 feet to the POINT OF BEGINNING, containing 0.002 acre, more or less, of which the present road occupies 0.000 acre and 0.002 acre is part of Franklin County Auditor's Parcel Number 010-126510.

The bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (1986 adjustment). Said bearings originated from a field traverse which was tied (referenced) to said coordinate system by Static GPS observations of Franklin County Engineering Department monuments Frank 43 and Frank 143. The centerline of Joyce Avenue, having a bearing of North 04° 07' 58" East, is designated the "basis of bearing" for this description.
