We look forward to this facility and what it brings to our neighborhood and a relationship that will prosper due to the commitment of all parties involved.

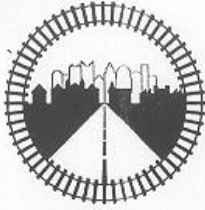
