The following investigation was conducted concerning the City of Columbus' 2016 – 2017 annual objection to the renewal of liquor permit held by Stooges Enterprises, LLC. at 2932 Noe Bixby Rd., Columbus, Ohio, doing business as Stooges. After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled with regard to the objection to the renewal of the permit issued to Stooges Enterprises, LLC. at 2932 Noe Bixby Rd., Columbus, Ohio by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 8601743. The permit holder received a D – 5 permit. This permits grants the permit holder the privilege to sell alcoholic beverages in the State of Ohio for on premise consumption as described by law.

An "Inquiry of Liquor Violations" was received from the State of Ohio, Division of Liquor Control. The "Inquiry of Violations" revealed that the permit holder has received the following violations:
