Sir,

The following investigation was conducted concerning the City of Columbus' 2022 annual objection to **0079740** issued to **Ahmads Petroleum Inc.**, which is doing business as **Sunoco**, located at **2725 W. Broad Street, Columbus, Ohio 43204**. The record owner of said permit is **Ahmad Aldamen**.

The City of Columbus has also objected to a permit transfer request at this location, new permit number **5381441**, requesting party, **MSS West Broad 2725 LLC**, requesting to do business as **Sunoco** at the same location. The record owner of this entity requesting the permit transfer is **Muhammad Sadiq**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **twenty-five (25)** official police reports concerning incidents at the listed liquor establishment between **January 2021** and **November 2022**. These reports referenced shootings, robberies, weapons offenses, recovered firearms, menacing, overdoses, domestic violence, underage tobacco sale, and assault, including:



In addition, the Columbus Division of Police and Division of Fire have been dispatched to **2725 W. Broad Street, Columbus, Ohio 43204** on **one hundred thirty-six (136)** calls for service, **one hundred three (103)** in 2021, and **thirty-three (33)** in 2022 at **Sunoco**. These calls for service include responses to a shooting, robberies, persons with a gun, shots fired, narcotics complaints, overdoses, intoxicated persons needing assistance, indecent exposure, assaults, fights, domestic violence, burglary, disturbances, and motor vehicle thefts.
