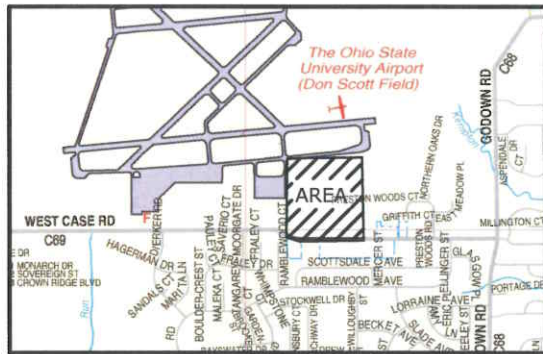

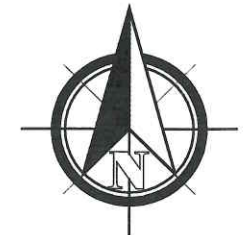
AREA SKETCH

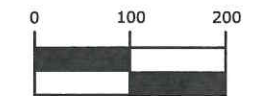

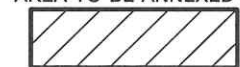
