Construction of the control/switchgear building foundation; Construction of underground concrete electrical ductbanks, manholes, and transformer vault at the site and within Spring Street, Long Street, and the Lower Scioto Greenway; Installation of all 15kV primary cable and control cables; and subsequent re-grading of the site and all other such work as may be necessary to complete the Contract.
6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**
Contract work is required to be completed in a manner acceptable to the City within 266 days from the date that a Notice To Proceed (NTP) is given by the City. The NTP is expected to be mid-July. There is a milestone of having the foundation installed by November 15, 2014 to be able to accept the control/switchgear building in early December.
7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

The new control/switchgear building will replace old obsolete switchgear and control panels. This will reduce maintenance costs for both labor and material. Also this project will provide new conductors from switchgear to existing manholes at the substation perimeter which will improve reliability to the distribution circuits. It will also provide a dedicated circuit to the Dublin Road Water Treatment Plant providing greater reliability to the Water Plant.

8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The bid amount and proposed award amount is \$3,777,974.80, including a 20% construction contingency amount that will be utilized to fund needed and approved changes in the work and a \$250,000.00 construction contingency for splices and terminations. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
