

**DESCRIPTION OF A 0.046 ACRE PARCEL  
PARCEL 15-WD**

Situate in the State of Ohio, Franklin County, City of Columbus, part of Lot Number 2 of Laura B. Koons Fairwood Frebis Parcels in Auditor's Plat Book 20 Page 527, part of Lot Number 1 of the Plat of Partition among the heirs of George W. McCloud recorded in Plat Book 7, Page 75, part of Stone & Chittenden's Subdivision half Section 33 recorded in Book 18, Page 241, Section 23, T5N, R22W, Refugee Lands, and being part of a 0.819 acre parcel conveyed to New Horizons Christian Fellowship, Inc. recorded in Instrument Number 201503250037255 in the Franklin County Recorder's office and being more particularly described as follows:

Being a parcel lying on the right side of centerline of Fairwood Avenue.

**Commencing** at an iron pin set on the east line of Half Section 32 and the west line of Half Section 33 at the intersection of Deshler Avenue at centerline station 10+00.00 and Fairwood Avenue at centerline station 35+55.52;

Thence South 04 Degrees 00 Minutes 49 Seconds West 349.19 feet along the centerline of Fairwood Avenue (50' right of way) being the east line of Half Section 32 and the west line of Half Section 33 to the grantors northwest corner and the southwest corner of a 0.95 acre parcel conveyed to Gregory Thomas and Yvonne C. Thomas recorded in Deed Book 3620, Page 105 at centerline station 32+06.33, said point being the **Point of Beginning** for the parcel herein described;

Thence from the **Point of Beginning** South 86 Degrees 11 Minutes 27 Seconds East 25.00 feet along the grantors north line and the south line of a 0.95 acre parcel conveyed to Gregory Thomas and Yvonne C. Thomas recorded in Deed Book 3620, Page 105 to an iron pipe found on the east right of way of Fairwood Avenue at 25.00 feet right of centerline station 32+06.42;

Thence South 04 Degrees 00 Minutes 49 Seconds West 80.44 feet along the east right of way of Fairwood Avenue to an iron pin set on the grantors south line and the north line of a 0.819 acre parcel conveyed to Edward B. Burgett and Mari R. Burgett recorded in Instrument Number 200505020081281, 200502230033205, 200502230033206, 200502230033207, 200502230033208, 200502230033209, 200502230033212 and 200502230033215 at 25.00 feet right of centerline station 31+25.98;

Thence leaving the east right of way of Fairwood Avenue North 86 Degrees 11 Minutes 27 Seconds West 25.00 feet along the grantors south line and the north line of said 0.819 acre parcel to the grantors southwest corner and the northwest corner of said 0.819 acre parcel at centerline station 31+25.89;

Thence North 04 Degrees 00 Minutes 49 Seconds East 80.44 feet along the grantors west line and the centerline of Fairwood Avenue being the east line of Half Section 32 and the west line of Half Section 33 to the **Point of Beginning**.

The above described contains 0.046 acres more or less including the present road which occupies 0.046 acres and is contained in Auditors Parcel Number 010-104323-00 which presently shows 0.819 acres.

Subject to all legal easements and rights of way.

All iron pins set are 3/4 inch diameter x 30 inch long rebar with a cap stamped "Canter S-7226".

All stations and offsets are referenced to the centerline of right of way of Fairwood Avenue.

Grantor claims title by Instrument Number 201503250037255 in the Franklin County Recorder's office.
