# MEMORANDUM OF UNDERSTANDING #2019-04 THE CITY OF COLUMBUS AND AFSCME, OHIO COUNCIL 8, LOCAL 1632

#### Regarding Old Sick Leave Bank

Pursuant to Section 32.3 of the Collective Bargaining Contract ("Contract") between the City of Columbus and the American Federation of State, County, and Municipal Employees, ("AFSCME") Ohio Council 8, Local 1632, the parties hereby agree to payout employees with Old Sick Leave Bank balances as defined under Article 20, Section 20.6 of the AFSCME, Local 1632 Contract.

#### TERMS:

- This Memorandum of Understanding #2019-04 (herein, "Agreement") only applies to those employees and their Old Sick Leave Bank balances listed in Appendix A, attached hereto.
- Pursuant to Article 20, Section 20.6, sick leave hours in an employee's Old Sick Leave Bank are valued by multiplying the number of unused sick leave hours by the employee's straight-time hourly rate in effect on March 31, 1987.
- Employees subject to this Agreement will be paid one hundred percent (100%) of the value of all sick leave hours in their Old Sick Leave Bank, less applicable tax withholding, as specified in Appendix A.

An ordinance will be submitted to City Council requesting its acceptance of this MOU, and the effective date will be established by City Council's acceptance.
