4. A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract

The work consists of all labor and materials for repair and rehabilitation of 14,826 feet of 8-inch diameter, 1,223 feet of 12-inch diameter, 1,431 feet of 15-inch diameter, 2,303 feet of 18-inch diameter and 1,311 feet of 21-inch diameter sanitary sewer utilizing Cured-in-Place Pipe (CIPP). The work includes cleaning, video inspection, lateral sewer reestablishment, bypass pumping, maintenance of traffic, open cut point repairs and other associated work. Rehabilitation of 73 manholes that includes replacement of frames and covers, cementitious lining, installation of manhole chimney flexible coating and such other work as may be necessary to complete the contract in accordance with the plans (CC14355) and

specifications. All of the work will be performed as a single phase with a duration of 270 days.

5. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract, and a projected ending date

The contract will be initiated in May of 2006 and will continue until the work is completed. The contractor will have 270 days to complete the contract without financial penalties.

6. An estimate of the full estimated cost of the contract including a separate estimate of any and all phases or proposed future contract modifications

The estimated (bid) cost of the work is \$1,274,980.80
