I. STATEMENT OF PURPOSE- Job Creation

The Department of Development recommends a Jobs Growth Incentive of 25% for a period of 4 years for the purpose of creating 88 new positions and retaining 31 positions within the City of Columbus.

II. PROJECT HISTORY

NuGrowth Solutions, LLC ("NuGrowth Solutions") is a business management firm that partners with businesses across the country and around the world to accelerate growth and enter new markets. With a proven methodology of professional sales, targeted eCommunications and effective new business development strategies, NuGrowth Solutions has boosted sales for hundreds of companies.

Strategic Insurance Software, LLC ("SIS") is a software developer and is a subsidiary of and managed by NuGrowth Solutions. SIS began in 1995 when a team of developers at State Auto Insurance created the Partner agency management system to meet the needs of the State Auto agents. As a result, SIS was established as a separate department of the major carrier. Recognizing the potential of the software, SIS started as a separate private business unit. Together, NuGrowth Solutions and SIS are proposing to expand their Columbus headquarters.

The company is also considering establishing a presence in Tampa, Florida or Raleigh, North Carolina for this expansion.

NuGrowth Solutions is requesting a Jobs Growth Incentive to assist in the expansion of its Columbus location.

The project will begin in February 2010 with a scheduled time of completion for December 31, 2012, contingent upon Columbus City Council approval of the recommended tax incentive.

V. EMPLOYMENT

NuGrowth Solutions and SIS will retain 31 full-time permanent employees with an annual payroll of \$873,946 and create 88 full-time permanent positions with an annual payroll of \$5,280,000.

Sequent is the outsourced human resources services provider to the companies and will co-employ the new employees.

VIII. WORKFORCE DEVELOPMENT

Employers granted a tax incentive will meet (within 90 days) with the Central Ohio Workforce Investment Corporation (COWIC) to develop a relationship to assure continuing employment opportunities for Columbus residents who are unemployed or underemployed.

IX. TAX BENEFIT

The recommended 25%/4 year Jobs Growth Incentive could yield cash payments totaling \$68,000 for NuGrowth Solutions and SIS over the incentive period.
