Thence North 86 degrees 33 minutes 11 seconds West, leaving said easterly existing right of way of Twentieth Street and the west line of said Lot 96, a distance of 1.50 feet across the right of way of Twentieth Street;

Thence North 03 degrees 26 minute 49 seconds East a distance of 76.26 feet across the right of way of Twentieth Street;
