Commencing for reference at the northwest corner of said Lot No. 457, being at the intersection of the south right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Burgess Avenue (50' public right of way);

thence along the north line of said Lot No. 457 and the south right of way line of said Mound Street, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for ten and 00/100 feet (10.00') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence continuing along said lines, South seventy-six degrees forty-five minutes fifty-seven seconds East (S76°45'57"E) for one hundred forty-five and 1/100 feet (145.01') to the northeast corner of said Lot No. 457, being the intersection of the south right of way line of said Mound Street with the west right of way line of the 1st Alley West of Richardson Avenue (20' public right of way);

thence along the east line of said Lot No. 457 and the west right of way line of said Alley, South thirteen degrees fourteen minutes three seconds West (S13°14'03"W) for ten and 00/100 feet (10.00');

thence leaving said lines across said Lot No. 457, North seventy-six degrees forty-five minutes fifty-seven seconds West (N76°45'57"W) for one hundred fifty-two and 94/100 feet (152.94');

thence continuing across said Lot No. 457, South twelve degrees fifty minutes three seconds West (S12°50'03"W) for nine and 65/100 feet (9.65');

thence continuing across said Lot No. 457, North seventy-seven degrees nine minutes fifty-seven seconds West (N77°09'57"W) for two and 00/100 feet (2.00') to the west line of said Lot No. 457 and the east right of way line of said Burgess Avenue;

thence along said lines, North twelve degrees fifty minutes three seconds East (N12°50'03"E) for nine and 67/100 feet (9.67');

thence leaving said lines across said Lot No. 457, North fifty-eight degrees two minutes three seconds East (N58°02'03"E) for fourteen and 9/100 feet (14.09') to the **TRUE POINT OF BEGINNING**, containing 0.0349 acres (1519.4 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
