This is a contract for the weekly, monthly and yearly maintenance of 7 boilers currently in use at the Southerly Wastewater Treatment Plant, a Division of Sewerage and Drainage (DOSD) facility. This contract provides the chemicals required for treating the water contained in the boilers at Southerly and Jackson Pike Wastewater Treatment Plants. This contract also provides the necessary maintenance and/or repairs of these boilers and the boilers at other DOSD facilities.
