Kokosing Construction Company provided information as it relates to the 'Good Faith Effort' section of the proposal. It is available for review upon request.

Please respond to this e-mail indicating approval of the recommended contractor – Kokosing Construction Company, Inc. – or approval of another contractor. If you approve another contractor please provide an explanation.

Note:

Kokosing Construction Company submitted a bid in which they removed the Responsible Contractor section of the bid document and replaced it with an already completed Responsible Contractor section. This is noteworthy because this section of the proposal document had been updated in consultation with the City Attorney's Office. This issue was discussed with the City Attorney's Office and the following opinion was provided: "It does not give them a competitive advantage and it does not make their bid non-responsive...."

Kokosing had 2 OSHA violations. They are listed below:

7/22/08, Other Violation, Medical Services and first aid, Abatement.

7/22/08, Other Violation, Criteria for personal protective equipment, Abatement.

Kokosing paid liquidated damages to ODOT (job number 14656, SR 309 Marion/Morrow Counties) in the amount of \$5320 for the project not being completed by the completion date.

Emergency Action:

Emergency action is necessary to allow for timely execution of this contract and construction to protect the safety and welfare of the public.
