Morningstar / North-Forty Street Lighting Imp's, CIP 670860-100000:

This project will involve the design of an underground street lighting system with decorative post top LED lights in the Morningstar / North-forty subdivision area of Columbus. This project will also design and incorporate the replacement of 5 existing underground light poles in the area. A new street lighting circuit will also be designed for this area as a result.

The community planning area is “52 – Westland” and includes the following streets: Sullivant Avenue, Coral Gate Drive, Wild Stallion Drive, and Galloway Road.

Circuit 30 Street Lighting Improvements, CIP No. 670871-100000

This project will involve the re-design of the total replacement of street lighting circuit #30. It will separate the overhead lighting and underground lighting into 2 circuits, as they currently exist as one (CKT #30).

The community planning area for this project is “41 – Northeast”.

The project will replace outdated street lighting which will result in an energy consumption savings for the City of Columbus. The addition of street lighting to the area may provide a sense of security to the residents, deter crime, and minimize potential impacts to City safety services.

The separation of circuit #30 into 2 circuits will improve on the reliability of lighting within the area. The existing HPS lighting will be converted to LED lighting, which will result in an energy consumption savings for the City of Columbus.

8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The bid amount and proposed award amount is \$239,049.03, including a 10% contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
