[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Section 27, ½ Section 40, Township 5, Range 22, Refugee Lands, being a strip of land located within that 0.186-acre tract as described in a deed to Saythong Praseutsack and Sypaphay C. Praseutsack, of record in Instrument No. 200602130027724, Recorder's Office, Franklin County, Ohio, said strip being on the LEFT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the southerly line of said 0.186-acre tract and the westerly right-of-way line of Lockbourne Road located 30.00 feet LEFT of station 74+04.37;

Thence North 86°14'28" West, along said southerly line, a distance of 5.00 feet to a point located 35.00 feet LEFT of station 74+04.36;

Thence North 03°54'25" East, parallel to said right-of-way line, a distance of 44.40 feet to a point in the northerly line of said 0.186-acre tract located 35.00 feet LEFT of station 74+48.76;

Thence South 86°16'16" East, along said northerly line, a distance of 5.00 feet to a point in the westerly right-of-way line of Lockbourne Road located 30.00 feet LEFT of station 74+48.78;

Thence South 03°54'25" West, along said right-of-way line, a distance of 44.41 feet to place of beginning.
