Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 53 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of Right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "FIRST CHURCH OF GOD, INC., A NON-PROFIT OHIO COPORATION" (hereafter referred to as Grantor) as described in Instrument No. 199802230039216 of the Franklin County Recorder's Office and being more particularly described as follows:

**COMMENCING** at a **1" Rebar Set** at the intersection of the existing centerlines of right-of-way of Refugee Road (width varies) and Schwartz Road (60 foot right-of-way) on the existing centerline of right-of-way of Refugee Road at station 28+89.33, also on the existing centerline of right-of-way of Schwartz Road at station 50+00.00;

**THENCE** with the existing centerline of right-of-way of Refugee Road, **North 85 deg. 43 min. 08 sec. West** for a distance of **42.47 feet** on the existing centerline of right-of-way of Refugee Road at station 28+46.85;

**THENCE** perpendicular with said centerline, **North 04 deg. 16 min. 52 sec. East** for a distance of **60.00 feet** to an **Iron Pin Set** on the North line of a 0.8986 acre tract designated as Parcel No. 12 as appropriated by the City of Columbus in Franklin County Court of Common Pleas Case No. 231507 as recorded in Deed Book 3017 page 301 in the North right-of-way line of Refugee Road and the Grantor's South line at 60.00 feet left of the existing centerline of right-of-way of

Refugee Road station 28+46.85 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

**THENCE** with the north line of said Parcel No. 12 in the North right-of-way line of Refugee Road and the Grantor's South line, **North 85 deg. 43 min. 08 sec. West** for a distance of **381.69 feet** to an **Iron Pin Set** at 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 24+65.16;

**THENCE** through the Grantor's lands the following four (4) courses:

- 1) **North 71 deg. 38 min. 40 sec. East** for a distance of **13.83 feet** to an **Iron Pin Set** at 65.32 feet left of the existing centerline of right-of-way of Refugee Road at station 24+77.92;
- 2) on a tangent curve to the right, with an **ARC LENGTH** of **60.01 feet**, a **RADIUS** of **152.00 feet**, a **TANGENT LENGTH** of **30.40 feet**, a **DELTA ANGLE** of **22 deg. 37 min. 12 sec.**, with a **CHORD BEARING** of **North 82 deg. 57 min. 16 sec. East** and a **CHORD DISTANCE** of **59.62 feet** to an **Iron Pin Set** at 77.03 feet left of the existing centerline of right-of-way of Refugee Road at station 25+36.38;
- 3) **South 85 deg. 44 min. 08 sec. East** for a distance of **227.00 feet** to an **Iron Pin Set** at 77.10 feet left of the existing centerline of right-of-way of Refugee Road at station 27+63.38;
- 4) on a tangent curve to the right, with an **ARC LENGTH** of **85.79 feet**, a **RADIUS** of **212.00 feet**, a **TANGENT LENGTH** of **43.49 feet**, a **DELTA ANGLE** of **23 deg. 11 min. 10 sec.**, with a **CHORD BEARING** of **South 74 deg. 08 min. 33 sec. East** and a **CHORD DISTANCE** of **85.21 feet BACK TO THE TRUE POINT OF BEGINNING**;

The above-described parcel contains 0.129 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-109331.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00

and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

All Iron Pins described as set are 5/8" x 30" rebar with a with a yellow plastic cap stamped "R/W Burgess & Niple" and shall be placed upon notification from the City of Columbus at the completion of construction.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
