

## **AMENDMENT SEVEN TO CONTRACT FOR SERVICES**

### **BETWEEN**

#### **SoundThinking AND THE CITY OF COLUMBUS, DEPARTMENT OF PUBLIC SAFETY**

This is Amendment Seven to the Contract for Services dated October 4, 2018 (the “Contract”), by and between SoundThinking and the City of Columbus, Department of Public Safety (“City”). Except as modified herein, all other terms and conditions of the Contract as previously amended remain in full force and effect. In the event of a conflict between the terms and conditions of the original Contract and this Amendment Seven, the terms and conditions of this Amendment Seven shall control. SoundThinking and City may also be referred to herein individually as a “Party”, or collectively as the “Parties”.

WHEREAS, the Contract and its Exhibits set forth the terms and conditions under which SoundThinking would provide its gunshot detection, location, and forensic analysis services to the City on an annual subscription basis; and

WHEREAS, the Contract was previously amended by Amendment One dated June 22, 2020; Amendment Two dated October 4, 2020; Amendment Three dated October 20, 2020; Amendment Four dated February 14, 2022; and Amendment Five dated October 5, 2022; Amendment Six dated February 22, 2023; and

WHEREAS, the Parties desire to extend the Contract for Phase 2 by an additional three years;

NOW, THEREFORE, the Parties agree as follows:

1. City desires, and SoundThinking agrees, to extend the City’s existing term of Phase 2 by an additional three years. Specifically, the extension of the term of Phase II shall be from June 30, 2024 to June 29, 2027.
2. City agrees to pay the annual fees for a three-year term as set forth in Exhibit A. Each annual fee of \$210,000 shall be subject to the annual appropriation of available funds by the City Auditor and approval by City Council.
