This project, Alum Creek Trunk Middle – Contract A, CIP 650725-100003, consists of CIPP lining of approximately 2,100 LF of 48” sanitary sewer, manhole rehabilitation and approximately 18,100 LF of 42” to 60” sanitary sewer cleaning and other such work as may be necessary to complete the contract, in accordance with the plans CC-16584 and specifications.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

Contract work is required to be completed in a manner acceptable to the City within 365 days from the date that a Notice To Proceed (NTP) is given by the City.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

This project will rehabilitate over 2,100 LF of large diameter sanitary sewer, reduce I&I into the sanitary system which will reduce the amount of clean water that the treatment plants process as well as remove all debris from the existing interceptor sewer, thus returning it to its full flow capacity.

8. **An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.**

The bid amount and proposed award amount is \$2,458,564.80, including a 20% construction contingency amount that will be utilized to fund needed and approved changes in the work.

No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
