The term of the contract is from April 1, 2005 through March 31, 2007.

There have been no modifications to date.

This modification is solely for the purpose of increasing the funding for the purchase of power line clearance (tree trimming) services. There is no modification to the terms or scope of the contract.

Power line clearance is an essential service that the Division of Electricity uses on an on-going basis. Severe weather in the winter of 2004-2005 caused a greater need for these services and the division had to increase the previous contract using 2005 budget authority. When the current contract was established, it was set up with only the remaining funds that had been budgeted in 2005 for this service. It has been determined that the reduced amount is insufficient to meet the need for these services.

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation)

The City has contracted with Asplundh Tree Expert Company to provide power line clearance services through March 2007. There is no change in the scope of the contract.

A cost summary to include the original contract amount, the cost of each modification to date (List each modification separately), the cost of the modification being requested in the legislation, the estimated cost of any future known modifications and a total estimate of the contract cost.

This contract was originally established in the amount of \$145,000. The modification being requested, in the amount of \$75,000, will provide sufficient funds to continue services through February 2006. After the 2006 budget passes, another modification for funding will be requested based upon annual budget authority authorized by City Council.
