Situate in Half Section 30, Township 5N, Range 22W, in the City of Columbus, County of Franklin, State of Ohio, and being part of a 0.089 acre tract of land, part of Lot 50 of Philip Schmitt's Second Subdivision recorded in Plat Book 7, page 21 as conveyed to Milverton Way LLC, an Ohio Limited Liability Company, by deed recorded in Instrument No. 201308020131089 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at the southeast corner of said 0.089 acre tract, said point being the intersection of the north right of way line of Frebis Avenue (50' public right of way) with the west right of way line of Ann Street (40' public right of way), 20.00 feet left of centerline Station 200+25.16;

thence along the south line of said 0.089 acre tract and the north right of way line of said Frebis Avenue, North eighty-six degrees one minute two seconds West (N86°01'02"W), for sixteen and 00/100 feet (16.00') to a point 36.00 feet left of centerline Station 200+25.22;

thence leaving said lines and across said 0.089 acre tract, North three degrees fifty-eight minutes fifty-eight seconds East (N03°58'58"E), for one and 84/100 feet (1.84') to a point 36.00 feet left of centerline Station 200+27.06;

thence continuing across said 0.089 acre tract, South eighty-six degrees one minute two seconds East (S86°01'02"E), for thirteen and 50/100 feet (13.50') to a point 22.50 feet left of centerline Station 200+27.04;

thence continuing across said 0.089 acre tract, North three degrees forty-four minutes thirty-five seconds East (N03°44'35"E), for thirty-three and 98/100 feet (33.98') to a point 22.50 feet left of centerline Station 200+60.98;

thence continuing across said 0.089 acre tract, South eighty-six degrees fifteen minutes twentyfive seconds East (S86°15'25"E), for two and 50/100 feet (2.50') to a point on the east line of said 0.089 acre tract and the west right of way line of said Ann Street, 20.00 feet left of centerline Station 200+60.98;

thence along said lines, South three degrees forty-four minutes thirty-five seconds West (\$03°44'35"W), for thirty-five and \$3/100 feet (35.83') to the POINT OF BEGINNING.

The above described area contains 0.003 acres (114.41 sq. ft.), more or less, of which the present road occupies 0.000 acres, more or less, which is part of the Franklin County Auditor's Permanent Parcel Number 010-010057.

The stations and offsets of the above description are measured from the proposed centerline of construction for Ann Street.

The bearings shown hereon are based on the centerline of Ann Street from Frebis Avenue to Whittier Street as being North 03° 44' 35" East, from an adjusted field survey using multiple VRS observations and/or direct GNSS measurements from Franklin County monuments FRANK 43, 973, and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum of 1983 (NSRS 2007) scaled to ground by 1.0000488019 about the projection false northing and easting (0, 1968500).
