

**Explanation**

**BACKGROUND:** Chapter 1710 of the Ohio Revised Code, effective September 29, 1994 provides for the creation of Special Improvement Districts (SID), by non-profit corporations governed by trustees elected by the property owners for the provision of special services in a designated district. The City of Columbus currently has five Special Improvement Districts (SIDS), they are the Capital Crossroads SID, Discovery SID, Short North SID, Morse Road SID, and the University District SID, all have been very successful. We now have a petition to approve a new SID in the East Main Street area, from Bexley to Whitehall, to be known as the "East Main Street Special Improvement District, (East Main Street SID). The property owners have initiated a one petition process in which the property owners of at least 60% of the front footage of all real property located within the District signed that they are interested in the creation of a SID and they approve of the Plan for Improvements and Services to be provided by the SID.

This legislation is one of the first actions required by Chapter 1710 of the Ohio Revised Code. City Council must approve the Initial Plan of Improvements and Services (attached) of the East Main Street Special Improvement District of Columbus, Inc., an Ohio not-for-profit corporation organized pursuant to Chapter 1710 of the Revised Code.

Companion legislation is being presented that approves the Petition and the Articles of Incorporation of the East Main Street Special Improvement District.

This legislation is for the approval of the Plan for Improvement and Services (Attached) to be provided by the East Main Street Special Improvement District of Columbus, Inc. pursuant to Ohio Revised Code Chapter 1710.

**FISCAL IMPACT:** No funding is required for this legislation.

**Title**

To approve the Initial Plan for Improvements and Services to be provided by the East Main Street Special Improvement District of Columbus, Inc., and to approve the property of the municipal corporation in said plan for improvements and services.

**Body**

**WHEREAS,** the property owners located in the East Main Street area have initiated a petition to create the East Main Street Special Improvement District (SID) and to approve the Initial Plan for Improvements and Services and have filed the Petition with the Columbus City Council along with the Articles of Incorporation for Special Improvement District, Inc. a non-profit corporation to be

responsible for the operation of the SID; and

**WHEREAS**, companion legislation to approve the Petition and Articles of Incorporation to create the Special Improvement District, Inc. is simultaneously being presented to Columbus City Council; and

**WHEREAS**, this legislation is for the approval of the Plan for Improvements and Services to be provided by the East Main Street Special Improvement District of Columbus, Inc. pursuant to Ohio Revised Code Chapter 1710; and

**WHEREAS**, the Clerk of Columbus City Council finds the property owners per the signed petition and the City per this resolution represents at least seventy-five percent (60%) of front footage of all property located in the East Main Street Special Improvement District per Section 1710; and

**WHEREAS**, it is the determination of the City Council that the Special Improvement District is a valuable tool for economic development and a means of continuing to improve the East Main Street area; NOW, THEREFORE:

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBUS:**

**SECTION 1.** That the Initial Plan of Improvements and Services, including the estimate of cost of the improvements and services to be provided by the East Main Street Special Improvement District of Columbus, Inc., now on file with the City Clerk are hereby approved.

**SECTION 2.** That the Mayor or his designee is hereby authorized to designate in writing that the City's property within the East Main Street SID is included under the Plan for Improvement and Services and may be assessed under the Plan for Improvement and Services.

**SECTION 3.** That the City Clerk is hereby directed to post a copy of this Resolution in the Office of the City Clerk as provided by Ohio Revised Code Chapter 1710.

**SECTION 4.** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.



ARTICLES OF INCORPORATION OF  
THE EAST MAIN STREET SPECIAL IMPROVEMENT DISTRICT OF COLUMBUS, INC.

The undersigned, desiring to form a nonprofit corporation under Chapter 1702 of the Ohio Revised Code ("ORC"), adopt the following Articles of Incorporation.

- FIRST: The name of this corporation is EAST MAIN STREET SPECIAL IMPROVEMENT DISTRICT OF COLUMBUS, INC. (hereafter referred to as the "Corporation").
- SECOND: The place in Ohio where the Corporation's principal office will be located is the City of Columbus, Franklin County, Ohio.
- THIRD: The corporation is formed for the following purposes:
- A. To govern a Special Improvement District created pursuant to ORC Chapter 1710.
  - B. To encourage and participate in programs that will maintain, improve and build the East Main Street corridor of Columbus as a viable business, cultural and residential community.
  - C. To assist the City of Columbus, Franklin County and other agencies and groups in providing programming which will preserve and enhance economic well-being and opportunity in the East Main Street corridor of Columbus.
  - D. To engage in any lawful act or activity for which corporations may be formed under ORC Chapter 1702 and amendments thereto, as may be deemed appropriate by the trustees of the Corporation, and to exercise any powers or rights now or hereafter conferred on nonprofit corporations under the laws of the State of Ohio which are in furtherance of any of the purposes for which the Corporation is formed.
  - E. To engage in any lawful act or activity for which corporations may be formed under ORC Chapter 1710 and amendments thereto, as may be deemed appropriate by the trustees of the Corporation.
  - F. The above enumerated purposes shall be interpreted in connection with the limitation that the Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code").
- FOURTH: The name of the Special Improvement District formed by the Corporation under ORC Chapter 1710 shall be the "East Main Street Special Improvement District."
- FIFTH: The territory within the District shall be generally described as that portion of the City of Columbus, Ohio which is located within the following area:

- A. Beginning at the southeast corner of Gould Road and East Main Street and proceeding east along East Main Street, then proceeding
- B. South along the western boundaries of Franklin County tax parcel numbers 010-087538 and 010-217331 along the east side of Barnett Road, then proceeding
- C. East along the southern boundary of Franklin County tax parcel number 010-217331, then proceeding
- D. North along the eastern boundaries of Franklin County tax parcel numbers 010-217331, 010-217330, and 010-088829, then proceeding
- E. West along the northern boundary of Franklin County tax parcel number 010-088293, then proceeding
- F. South along the western boundaries of Franklin County tax parcel numbers 010-088293 and 010-088364, then proceeding
- G. West along the north side of East Main Street until reaching the corner of Gould Road and East Main Street.

A detailed listing of all property included in the District, as identified by its current tax parcel number assigned by the Franklin County Auditor's Office, is attached hereto as Exhibit 1.


SIXTH: Each owner of real property within the District, other than the State of Ohio, Franklin County, the City of Columbus, the United States of America, or the owners of any Church Property (as such term is defined in ORC Section 1710.02) will be a member of the District ("Members"); provided, however, that Franklin County, the City of Columbus, or the owners of any Church Property, as the case may be, shall be Members to the extent (but only to the extent) that they voluntarily submit to the District and to the provisions of Chapter 1710 all or a portion of their real property in the District, as provided by Chapter 1710. Members shall have such voting rights as described in the Code of Regulations of the Corporation.

SEVENTH: The Board of Trustees of the Corporation shall consist of at least four (4) individuals, one of whom shall be the Chief Executive of the City of Columbus, or alternately an employee of the City of Columbus who shall serve at the pleasure of the Chief Executive, and the remainder of whom shall be Members or executive representatives of Members elected by the Members.

The Incorporators, whose names and addresses are set forth at the end of these Articles, plus two (2) temporary Trustees to be appointed by the Incorporators, shall serve the Corporation as Trustees until the election of Trustees, which will occur at the first meeting of the entire membership or thereafter at the annual meeting of the District after its creation. The Trustees of the Corporation from time to time shall constitute the Board of Directors of the Special Improvement District under ORC Chapter 1710.

- EIGHTH:** These Articles may be amended only (a) by the vote of Members entitling them to exercise a majority of the voting power on such proposal, and (b) after receipt of approval of such amendment or amended articles by resolution of the legislative authority of the City of Columbus, and (c) upon filing of such amendment or amended articles and a certified copy of such resolution with the Ohio Secretary of State.
- NINTH:** The District is being created by concerned landowners in the District in an effort to enhance economic vitality, livability, and commerce in the East Main Street corridor of Columbus. The district is intended to increase the use of East Main Street by businesses and individuals in the Columbus metropolitan area, thereby better establishing East Main Street as a clean and safe business district which will in return be conducive to the public health, safety, peace, convenience, and welfare of the District.
- TENTH:** No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code or (b) by a corporation, contributions to which are deductible under Section 501(c)(2) of the Code.
- ELEVENTH:** Upon the dissolution of the Corporation, all assets remaining after paying or making provision for the payment of all of the liabilities of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.





**PETITION TO CREATE THE EAST MAIN STREET  
SPECIAL IMPROVEMENT DISTRICT**

**IMPORTANT INFORMATION ABOUT THIS PETITION**

You are being asked to execute a Petition for Creation of the East Main Street Special Improvement District of Columbus.

The proposed boundaries of the district will consist of assessable properties in the City of Columbus, running from the boundary with Bexley on the west to the boundary with Whitehall on the east. This is a distance of approximately 1 mile. Creation of the District requires the approval of property owners representing at least 60% of the property within District boundaries, based upon front footage.

When circulation of this petition has been concluded, the petition will be presented to the Columbus Mayor and City Council. You may withdraw your signature from the petition at any time prior to its presentation to the City.

If enough signatures are gathered and the petition is approved by City Council, you should expect the following:

1. A non-profit corporation will be formed.
2. All of the property owners in the District will be members of the non-profit corporation and will elect a Board of Trustees comprised of property owners. The City of Columbus will also appoint at least one representative to serve on the Board.
3. An assessment will be levied against all of the properties in the District based on the taxable value of each property. This assessment will amount to approximately 7.5 percent of each property owner's annual property taxes. The assessments will be collected, beginning no earlier than 2017 in the same manner as real estate taxes and forwarded to the non-profit corporation to pay the costs of providing the improvements and/or services set forth in the plan adopted by the Board of Trustees. Thus, property owners in the District will remain in control of the use of the assessment monies.
4. The Board of Trustees will use the assessments to implement the service plan outlined in the petition.
5. If the required property owner approvals are not obtained on the petition, then the non-profit corporation will not be formed and no assessments will be levied.



## PETITION TO CREATE THE EAST MAIN STREET SPECIAL IMPROVEMENT DISTRICT

*To: The Mayor of the City of Columbus, Hon. Andrew J. Ginther, and Columbus City Council.*

The undersigned do hereby respectfully petition the City of Columbus (the "City") for the creation of the **East Main St. Special Improvement District of Columbus** (the "District") pursuant to Section 1710 of the Ohio Revised Code and amendments thereto (the "Act"). The **District Boundaries** will be as described and shown in Exhibit A attached hereto and made a part hereof.

Each of the undersigned represents that he or she is the owner, or the authorized signatory of the owner, of the property or properties set forth below, which collectively comprise at least sixty percent (60%) or more of the front footage of property abutting upon the streets, alleys, public roads, places, boulevards, parkways, park entrances, easements, and other public improvements situated in the District.

In support of this petition, the undersigned petitioners approve the following:

1. **Mission.** The mission of the District will be to enhance the value of properties within the District by carrying out the improvements and/or services in and for the benefit of the District as the Board (defined below) may determine and funds may allow, all as set forth in the Service Plan.
2. **Corporate Entity and Governance.** The operations and fiscal affairs of the District will be managed and administered by the Board of Trustees (the "Board") of East Main St. Special Improvement District of Columbus, Inc., an Ohio not-for-profit corporation to be formed for such purpose. The Board will consist of at least four (4) individuals and will have all powers authorized by the Act. At least three (3) trustees will be elected by the property owners in the District, and at least one (1) will be an appointee of the City of Columbus.
3. **Authority.** The District will be authorized to provide services and improvements pursuant to the Act that will benefit property within the boundaries of the District. The City will be authorized to levy a special assessment on property within the District to pay for such services and improvements, based on the benefits conferred by those services and improvements.
7. **Boundaries.** A description of the boundaries of the District, a map showing the boundaries of the District, and a definitive listing, as identified by parcel number, of properties to be included in the District are provided in Exhibit A.
8. **Miscellaneous.** The undersigned acknowledge that the District is being created using the single petition option under the Act and that no further authorization by property owners will be required for the District to be created and the Service Plan to be implemented.

This petition may be executed in several counterparts, each of which will be an original and all of which will constitute one and the same instrument.

The Columbus City Council is hereby respectfully requested to approve, by resolution, this petition to create the East Main St. Special Improvement District and adopt the Service Plan within sixty (60) days of this Petition being filed with the City.

### EXHIBIT A

#### EAST MAIN STREET SPECIAL IMPROVEMENT DISTRICT BOUNDARIES

This Exhibit A defining the boundaries of the East Main Street Special Improvement District of Columbus (the "District") consists of three parts, which are to be viewed in combination.

The three parts are:

1. A general description of the area of the District.
2. A map showing the approximate boundaries of the District.
3. A definitive listing of properties to be included in the District, which are identified by parcel number.

1. General Description: The District will generally consist of assessable properties facing East Main Street from Gould Road on the west to Barnett Road on the east, including 3 parcels to the east of Barnett Road. This is a distance of approximately 1 mile. This is the section of East Main Street in Columbus which is bounded by the City of Bexley on the west and the City of Whitehall on the east.

**PLAN OF SERVICES & BUDGET**

The total budget is \$54,000 per year at a 7.5 percent special assessment on property taxes. This tax assessment will pay for unarmed safety patrols, on bicycle and on foot, with a direct connection to the Columbus Police Department. The tax assessment will also fund litter pickup along Main Street. At \$10 per hour and 10 hours per week, litter pickup will cost \$5,200 annually.

If other funds are secured from the City of Bexley, COTA or other sources, services will be increased proportionally. To pay for 40 hours of Community Crime Patrol time, which costs \$70,720, we will require outside funding.

All other projects, like beautification, landscaping and lighting, will be financed through private donations, government contributions, and/or grant funding.
