**Subject:** Intersection Improvements – Roberts Road at Spindler Rd.

The Department of Public Service solicited Requests for Proposals for the Intersection Improvements – Roberts Road at Spindler Road Contract. The budget is \$450,000 funded by the 2012 CIB.

The intent of this project is to provide the City of Columbus preliminary and final engineering for improvements to the intersection of Roberts Road at Spindler Road. Design will proceed in two parts. The specific scope of work for Part 2 will be developed upon completion of Part 1. It is anticipated that the constructed project will install a traffic signal at the intersection of Roberts Road at Spindler Road and widen Roberts Road at this intersection to install a westbound left turn lane. Additional improvements will be determined upon completion of a traffic study of both the Roberts at Spindler intersection and the Roberts at Frazell intersection. Alternatives will be developed with considerations to complete street improvements and to the recently completed Franklin County Engineer and ODOT projects in the area. Part 1 will determine the major project elements. The remaining Preliminary Engineering and Final Engineering will be performed in Part 2.

The project was formally advertised on the Vendor Services web site from November 29, 2012, to December 20, 2012. The city received six (6) responses. All proposals were deemed responsive and were fully evaluated when the Evaluation Committee met on January 10, 2013. The responding firms were:
