This is a contract for the annual inspection, certification, submittal of an annual report discussing the findings of inspections, and needed maintenance and repairs or replacement of the approximately 138 cranes and hoists, and a number of hoisting appurtenances, all in use in the facilities of the Division of Sewerage and Drainage. This specialized work is needed to provide safety-rated operational and maintenance facilities. Additional Department of Public Utilities facilities may be included in the future. With this modification, revisions to the technical specifications are made to address periodically updating the equipment lists to facilitate the maintenance of new equipment to be added and existing equipment that is replaced or removed from service.

An updated contract timeline to contract completion.

- Year 2 December 2, 2012 through December 1, 2013**
- Year 3 December 2, 2013 through December 1, 2014**

The contract will continue to provide Crane & Hoist Equipment Maintenance Services for the SWWTP, JPWWTP, SMOC and Compost Facility. Recently, additional Crane & Hoist equipment from capital improvement projects' construction has been turned over to the wastewater treatment plants and will require the annual inspection, monitoring and maintenance services provided under this contract. This modification provides revision of the technical specifications to permit the periodic updating of the equipment lists as new equipment is added and existing equipment is replaced or removed from service.

If the contract modification was not anticipated and explained in the original contract legislation a full explanation as to the reasons the work could not have been anticipated is required. Anticipated modification. The original contract allows for two (2) extension periods on a year to year basis. This modification is to provide the funding necessary for the payment of services to be provided through December 1, 2014.

The same exact service is required as originally bid. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with modifications on approximately an annual basis. Two contract modifications are anticipated at this time.
