Scott Wilson provides the following background for 1966-2006

Since Finance rejected the original legislation of \$300,000 for all our equipment we asked Joe Lombardi to break it up into two separate pieces which DoT said they would support.

From that Joe wrote two separate requests:

 for \$70,000 to purchase blade servers to replace the existing flock of out-of-date and rapidly failing servers with blade servers (already on the agenda).
this legislation to spend \$225,000 on the 2006 PC Refresh for Fairwood and the plants (non-SCADA PCs).

We intentionally held off the DOSD refresh because we wanted to wait DoT had control over all Utility desktops so they could install the new machines with their standardized image. At about \$1,000 per PC, this will buy 225 machines. This will cover the DOSD 2006 refresh and allow updates to the plants and other key SPL users because their PCs have been especially slowed down by the DoT anti-virus updates earlier this year.
