Installing ~1,000 linear feet of 12-inch water line and appurtenances in the right-of-way of Alton-Darby Creek Road, and such other work as may be necessary to complete the contract in accordance with the plans and specifications.

The Notice to Proceed is estimated to be issued in Spring 2010. All construction work shall be completed within 45 calendar days after the date of the Notice to Proceed.
