Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 8, Section 7, Township 12 N, Range 21 W, Refugee Lands and being part of Lot 12 of Mayfair as recorded in Plat Book 19, Page 40 and conveyed to D R Israel, LLC, an Ohio limited liability company in Instrument 201704270056556 in the Franklin County Recorder's Office. The below described parcel laying on the right side of the centerline of existing right of way for James Road in project James Road at East Broad Street as platted by 2LMN, Inc. as recorded in Instrument 202108240151066, and being more particularly described as follows:

COMMENCING at a point at the grantor's southwest corner, being the southwest corner of said lot 12 and on the easterly existing right of way for James Road, said point being 40.00 feet right of centerline of existing right of way for James Road at station 56+40.18 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the grantor's west line and the easterly existing right of way for James Road, **North 04 degrees 04 minutes 04 seconds East, 29.82** feet to an iron pin set, said pin being 40.00 feet right of the centerline of existing right of way for James Road at station 56+70.00;
- 2) **Thence**, across the grantor's tract, **North 35 degrees 01 minutes 53 seconds East, 11.66** feet to an iron pin set, said pin being 46.00 feet right of the centerline of existing right of way for James Road at station 56+80.00;
- 3) **Thence**, across the grantor's tract, **South 04 degrees 04 minutes 04 seconds West, 39.82** feet to a point, said point being 46.00 feet right of the centerline of existing right of way for James Road at station 56+40.18;
- 4) **Thence**, across the grantor's tract, **North 85 degrees 55 minutes 39 seconds West, 6.00** feet to the **TRUE POINT OF BEGINNING**, containing 0.005 acres.
