This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Resurfacing – Resurfacing 2010 Project 1.

<u>Project Scope:</u> This contract is to repair and resurface 16 city streets and construct 152 ADA curb ramps along those streets. The work consists of milling the existing pavement, overlaying with new asphalt concrete, replacing curb and sidewalk associated with installing ADA wheelchair ramps. Where warranted, the plan also calls for areas of partial depth pavement repair.

<u>Fiscal Impact:</u> Project shall be funded from 2009 bond sale monies.

<u>Schedule:</u> Bids were opened on January 21, 2010. The contract length is 120 days from the date of the Notice to Proceed. The Notice to Proceed date is estimated to be March 29, 2010.

# Recommendation:

With reference to bids received on January 21, 2010, I wish to make the following recommendation for the subject improvement:

Award is made to the lowest responsive and responsible and best bidder, Kokosing Construction, for their bid of \$3,202,859.07, which is \$511,733.45 under the Engineer's estimate of \$3,714,592.52.

Please note that all the other bids received are fundamentally equivalent (i.e. within 10% of the low bid after credit) to Kokosing Construction's bid.

Please respond to this e-mail indicating approval of the recommended contractor – Kokosing Construction – or approval of another contractor. If you approve another contractor please provide an explanation.

## NOTE:

Kokosing has a record of liquidated damages paid in the past three years: ODOT project, SR 309 Marion/Morrow Counties, \$5,320. Not completed by ODOT completion date.

Kokosing has a "serious" OSHA violation in the past three years: ODOT project US Rt. 23 Bridge #2020; 1) ring bouys with at least 90 feet of line were not provided and readily available for emergency rescue operations, 2) A lifesaving skiff was not immediately available at locations where employees were working over or adjacent to water.

### **Emergency Action:**

Emergency action is necessary to allow for timely execution of this contract and construction to protect the safety and welfare of the public.
