The following investigation was conducted concerning the City of Columbus' 2020 annual objection to the renewal of liquor permit **4410458** issued to **Jumanah LLC**, which is doing business as **McGuffey Market** located at **1066 East Hudson Street, Columbus, Ohio 43211**. The recorded owner of said permit is **Abdallah M Elwawi**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations in **2019** and **2020**:

In addition, the Columbus Division of Police have been dispatched to **1066 East Hudson Street, Columbus, Ohio 43211** on **(122) one hundred twenty-two** calls for service, **(68) sixty-eight** in 2019, and **(54) fifty-four** in 2020 at **McGuffey Market**. These calls for service include responses to shootings, persons with guns, persons with knives, assaults, robberies, accidental overdoses, O.V.I., fights and disturbances, persons needing medical assistance, domestic violence, stolen vehicle, and narcotics complaints.
