Temporary Construction Easement

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Half Section 40, Section 27, Township 5, Range 22 of the Refugee Lands and being part of a 0.557 acre tract as described in a deed to Vahid G Hagee and Neda Nassirzadeh in Instrument Number 200009130184858, all records on file in the Recorder's Office, Franklin County, Ohio, and said parcel being more fully described as follows:

**Commencing** at the northeasterly corner of Lot 37 of Max Borst Addition as shown in Plat Book 10 page 394, being the intersection of the southerly right of way of Sheldon Avenue and the westerly right of way of Lockbourne Avenue;

Thence South  $03^{\circ} 53' 44''$  West, following the westerly right of way of Lockbourne Avenue, for a distance of 474.86 feet to a  $5/8''$  iron pin found with a PS 7740 identifying cap on the northerly line of said 0.557 acre tract and the southerly line of a 0.186 acre tract as described in a deed to Saythong Praseutsack and Sypaphay C. Praseutsack in Instrument Number 200602130027724;

Thence North  $86^{\circ} 27' 37''$  West, following the line thereof, for a distance of 9.20 feet to the **True Place of Beginning** of the parcel herein described;

Thence South  $03^{\circ} 53' 44''$  West, passing through said 0.557 acre tract, for a distance of 79.34 feet to the southerly line of said 0.557 acre tract and the northerly line of a 0.379 acre tract as described in a deed to The Columbus Baptist City Mission Society in Deed Book 1915 page 129;

Thence North  $86^{\circ} 00' 23''$  West, following the line thereof, for a distance of 5.00 feet to a point;

Thence North  $03^{\circ} 53' 44''$  East, passing through said 0.557 acre tract, for a distance of 79.30 feet to the northerly line of said 0.557-acre tract and the southerly line of said 0.186-acre tract;

Thence South  $86^{\circ} 27' 37''$  East, following the line thereof, for a distance of 5.00 feet to the **True Place of Beginning**, and containing within said bounds 397 square feet or 0.009 acres of land, within Franklin County Auditor Parcel No. 010-024442, more or less, of which 0.000 acres are in present road occupied.

North for the above description is based on the centerline of Lockbourne Avenue as being North  $03^{\circ} 53' 44''$  East as established from an RTN/GNSS survey on June 27, 2019, and referenced to the Ohio State Plane Coordinate System, NAD83 (2011), South Zone.
