Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 7, Section 7 Township 12 N, Range 21 W, Refugee Lands and being part of Lot 16 of Broadleigh East as recorded in Plat Book 14, Page 25 and conveyed to Timothy C. Newton in Official Record 25298 and Page H16 in the Franklin County Recorder's Office. The below described parcel laying on the left side of the centerline of existing right of way for James Road in project James Road at East Broad Street as platted by 2LMN, Inc. as recorded in Instrument 202108240151066, and being more particularly described as follows:

COMMENCING at an iron pin set on the grantor's south line, the south line of lot 16, the north line of lot 15, being North 86 degrees 36 minutes 36 seconds West, 9.13 feet from a point at the southeast corner of said Lot 16 and the northeast corner of lot 15, said pin being 39.13 feet left of centerline of existing right of way for James Road at station 66+41.96 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the south line of said Lot 16 and north line of Lot 15, **North 86 degrees 36 minutes 36 seconds West, 4.00 feet** to a point, said point being 43.13 feet left of the centerline of existing right of way for James Road at station 66+41.97;
- 2) **Thence**, across the grantor's tract and lot 16, **North 06 degrees 15 minutes 53 seconds East, 60.08 feet** to a point on the grantor's north line, the north line of lot 16 and the south line of lot 17, said point being 40.00 feet left of the centerline of existing right of way for James Road at station 67+01.96;
- 3) **Thence**, along the north line of said Lot 16 and the south line of Lot 17, **South 86 degrees 36 minutes 36 seconds East, 4.00 feet** to an iron pin set, said pin being 36.00 feet left of the centerline of existing right of way for James Road at station 67+01.95;
- 4) **Thence**, across the grantor's tract and lot 16, **South 06 degrees 15 minutes 45 seconds West, 60.08 feet** to the **TRUE POINT OF BEGINNING**, containing 0.006 acres.
