Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 7, Section 7, Township 12 N, Range 21 W, Refugee Lands and being part of Lot 12 of Broadleigh East as recorded in Plat Book 14, Page 25 and conveyed to Harvey Wilson in Official Record 34517 and Page F12 in the Franklin County Recorder's Office. The below described parcel laying on the left side of the centerline of existing right of way for James Road in project James Road at East Broad Street as platted by 2LMN, Inc. as recorded in Instrument 202108240151066, and being more particularly described as follows:

COMMENCING at an iron pin found on the grantor's south line being North 86 degrees 36 minutes 36 seconds West, 17.62 feet from the southeast corner of said Lot 12, said pin being 47.62 feet left of centerline of existing right of way for James Road at station 64+01.97 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the south line of said Lot 12 and north line of Lot 11, **North 86 degrees 36 minutes 36 seconds West, 9.38 feet** to a point, said point being 57.00 feet left of the centerline of existing right of way for James Road at station 64+01.99;
- 2) **Thence**, across the grantor's tract, **North 04 degrees 03 minutes 11 seconds East, 60.00 feet** to a point on the grantor's north line, said point being 56.19 feet left of the centerline of existing right of way for James Road at station 64+61.99;
- 3) **Thence**, along the north line of said Lot 12, **South 86 degrees 36 minutes 36 seconds East, 10.69 feet** to an iron pin set, said pin being 45.50 feet left of the centerline of existing right of way for James Road at station 64+61.97;
- 4) **Thence**, across the grantor's tract, **South 05 degrees 18 minutes 28 seconds West, 60.03 feet** to the **TRUE POINT OF BEGINNING**, containing 0.014 acres.
